- 4. Voting Centre: (Column No.9) voters are requested to indicate the preferred voting centre viz., Pachaiyappa's College at Chennai (or) Pachaiyappa's College for Men at Kanchipuram (or) C. Kandaswami Naidu College for Women at Cuddalore, where he / she prefers to exercise his / her franchise. He / She will not be permitted to exercise his / her franchise in any other centre, except the centre of option.
